

Privacy Policy

These policies outline the rules for processing personal data of Patients and Users of the website Jacek Bil Olga Możeńska Medical Solutions civil partnership based in Warsaw www.jomedicalsolutions.eu. Personal data is processed by the Administrator in accordance with the provisions of the Regulation of the European Parliament and Council 2016/679 of April 27, 2016, on the protection of natural persons in relation to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC ("GDPR") and the Act on Providing Electronic Services.

1. PRIVACY POLICY OF THE WEBSITE

Who is the Data Administrator?

The administrator of personal data processed in connection with the use of the website www.jomedicalsolutions.eu is Jacek Bil Olga Możeńska Medical Solutions civil partnership based in Warsaw, ul. Quo Vadis 1/U6, 02-495 Warsaw, NIP 5272859816, REGON 380829400.

What data is processed?

In connection with the use of the website, the following data is processed:

1. Provided voluntarily by the User – in the content of the contact form,
2. Automatically recorded data contained in cookies – more about the rules for processing automatically collected data in the Cookie Policy section.

On what basis is the data processed?

Data provided by the User in the contact form is processed:

- Based on Article 6(1)(a) of the GDPR – for the purpose of marketing the Administrator's products/services,
- Based on Article 6(1)(f) of the GDPR and Article 9(2)(f) of the GDPR – for the purpose of pursuing or defending claims,
- Based on Article 6(1)(f) of the GDPR – to secure the legally justified interests pursued by the Administrator, including maintaining efficient and secure IT systems – by

ensuring the continuity of operations and data security, handling inquiries, servicing equipment and IT systems, as well as ensuring security at the Administrator's premises – by conducting monitoring of publicly accessible areas at the Administrator's location.

To whom is the data shared?

In connection with the Administrator's use of an external email hosting and website hosting service provider, the entities processing data related to the use of the site will be the hosting service providers.

How long is the data stored?

Data is stored until the expiration of potential claims of the User related to the inquiry directed to the Administrator and the response provided. In the case of data shared based on consent, data is stored until the consent for processing is withdrawn.

What rights does the User have?

By providing data, the User has the right to access the data and receive a copy, the right to rectify (correct) the data, the right to request deletion, restriction of processing, or to object to data processing, data portability, and the right to withdraw consent to processing to the extent that data is processed based on consent. Withdrawal of consent does not affect the lawfulness of processing carried out based on consent before its withdrawal. To exercise the rights, the User should contact the Administrator in writing at the correspondence address or by sending an email to contact@jomedicalsolutions.eu.

Is processing subject to oversight by a supervisory authority?

If it is deemed that data processing violates legal provisions, in addition to contacting the Administrator, the User has the right to lodge a complaint with the supervisory authority, i.e., the President of the Personal Data Protection Office.

Data profiling

Decisions made by the Administrator regarding data processing are not made automatically. User data is not subject to profiling.

2. COOKIE POLICY

Who is the Data Administrator?

The entity placing cookies on the User's devices and the Administrator of personal data obtained from them is Jacek Bil Olga Możeńska Medical Solutions civil partnership based in Warsaw, ul. What are cookies?

Cookies are IT data, in particular text files, which are stored on the User's end device (e.g., computer, tablet, phone), intended for use on the website. The files contain an identifier of the page from which they come, the time they are stored on the User's device, and a unique number.

What are cookies used for?

Cookies allow for more convenient use of the website, including by adapting its content to the settings of the device used by the User. Cookies can also be used to create usage statistics for the website, allowing it to be adapted to the needs of users.

What types of cookies are used?

Different types of cookies are used on the site:

- **Necessary cookies** – enabling the use of services available on the site,
- **Security cookies** – allowing the detection of abuse,
- **Performance cookies** – enabling the collection of information on how the website is used,
- **Functional cookies** – allowing the memorization of User settings and adapting the site to their preferences,
- **Statistical cookies** – allowing the conducting of usage statistics for the site,
- **Advertising cookies** – allowing the delivery of advertising content tailored to the User's revealed interests.

Is it possible to disable the use of cookies?

In most cases, web browsers automatically allow the storage of cookies on the User's device. At any time, the User can change these default settings, particularly to block automatic handling of cookies in the browser or to be informed each time cookies are placed on the device. Detailed methods for regulating access to cookies are available in the settings of the web browser used by the User.

Is it possible to use the site without cookies?
